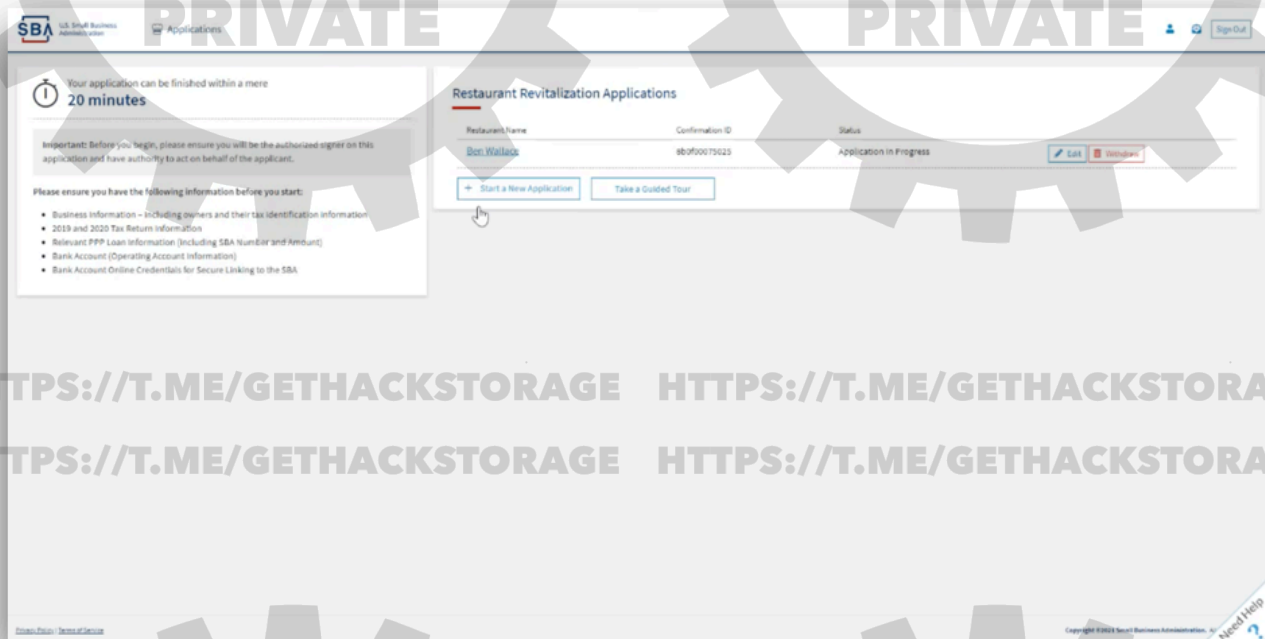


# GET HACK STORAGE PRIVATE SBA RRF. Часть 2

Добрый вечер, друзья, продолжаем наш мануал по SBA RRF. Сегодня пройдем подачу заявления. Итак, первым делом, после регистрации или входа в аккаунт, мы видим перед собой такую картину. У кого холдер уже подавал заявку, отобразится то, что на скрине ниже. Так же будет высвечиваться ваша первая заявка после успешного заполнения, тут её можно отслеживать.



Далее мы приступаем к подаче нового заявления.



Сумма, что вы видите слева в углу отобразится у вас в нужном разделе заявления. Будем проходить всё кратко, так как информации надо заполнять много. На первой странице везде ставим "NO". Идём дальше.

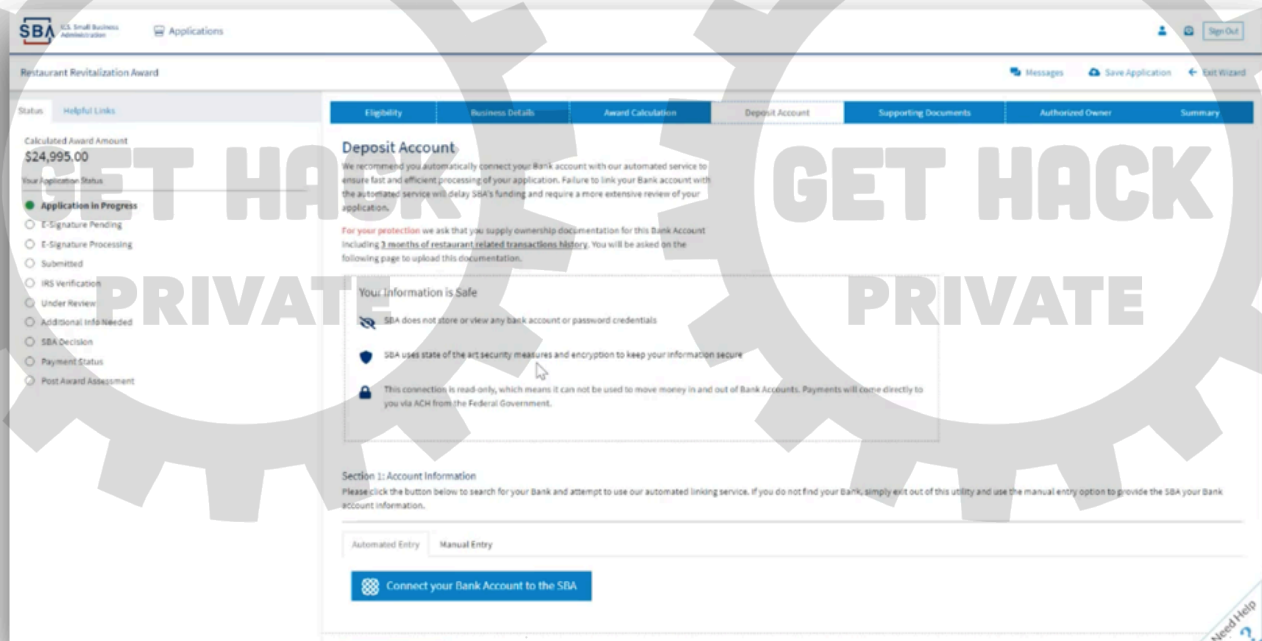

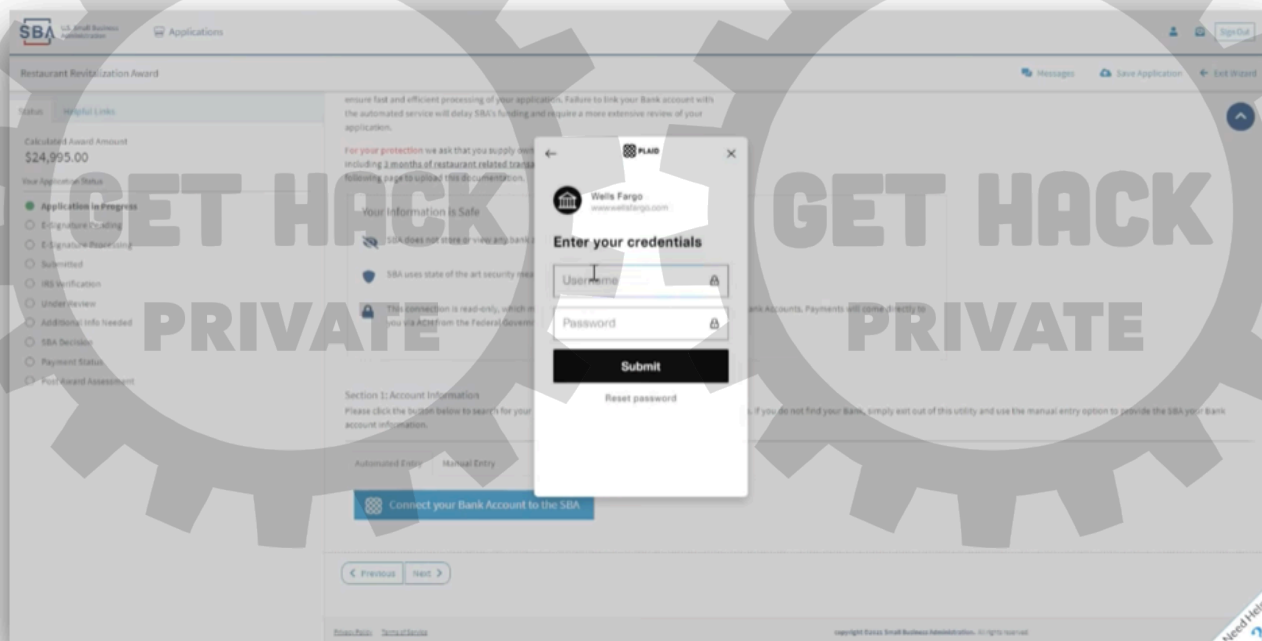
The form instructs the user to 'Choose the appropriate Calculation Method below to determine your Award Amount. Your final calculated award amount must be no less than \$1,000.' There are four options:

- Table 1**: Calculation of funding for applicants that were in operation prior to or on January 1, 2019.
- Table 2**: Calculation of funding for applicants that began operations partially through 2019.
- Table 3**: Calculation of funding for applicants that began operations on or between January 1, 2020 and March 10, 2021, and for Applicants that have not yet opened but as of March 11, 2021, have incurred eligible expenses.
- Table 4**: Select this option if either of the following pertains to you.
  - You have multiple restaurants that fall in a combination of the above options, and you need to aggregate these methods. Provide a total funding request based on your calculations. Supporting detail will be required during the documentation upload step, and/or
  - You are applying as part of a corporate group or have affiliates and your total calculated award would otherwise exceed the \$10 million aggregate limit, in which case this option allows you to reduce your total award request or align.

Секция 3. Заполняется исходя из данных вашей фулки, если не знаете что ставить, выбирайте - первое. По суммам всё зависит исключительно от вашей фулки и холдера, что за предприятие и сколько оно зарабатывает. Тут можно написать интуитивно, в большинстве случаев эта сумма между \$20.000 и \$100.000.



Следующий раздел с заполнением данных банковского аккаунта. Советую вязать плайдом, если есть такая возможность, так же желательно оформлять стандартные банки по типу Чейза или Сантраста ( Биз. счета ), опять же если есть возможность и умеете их налить, если не очень, то берите различные бизнес всс-конторы, однако их придётся привязывать по анрн, что добавит пару дней к вашему времени заполнения.



После привязки банковского аккаунта переходим к 4му этапу.

Этап загрузки отрисованных документов. Загружаем как в форме ниже.

При возникновении различных трудностей по типу, ваши документы весят больше положенного, переходите по кнопке справа внизу в углу и решайте вопрос.

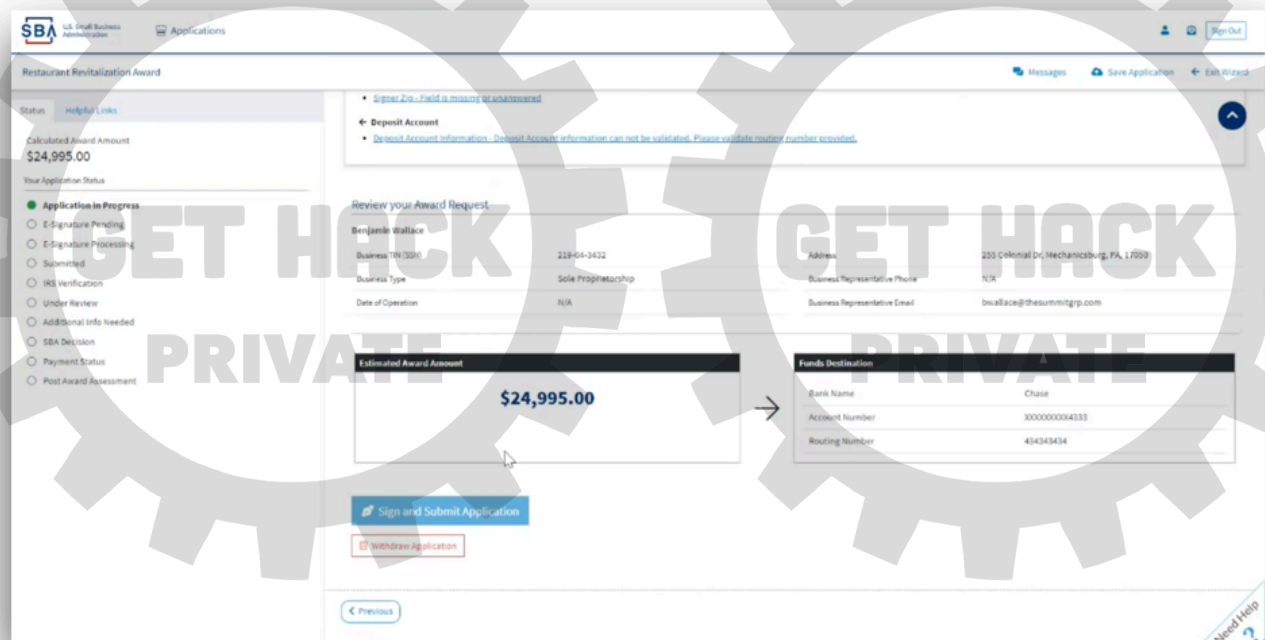

Далее попадаем в раздел заполнения данных о заявителе. Если вы заполняете от лица самозанятого, пишем всё те же самые данные холдера что и в информации о бизнесе. Если вы заполняете данные от лица какой-то крупной компании, то пробейте данные на любого из владельцев и заполняйте от его лица.

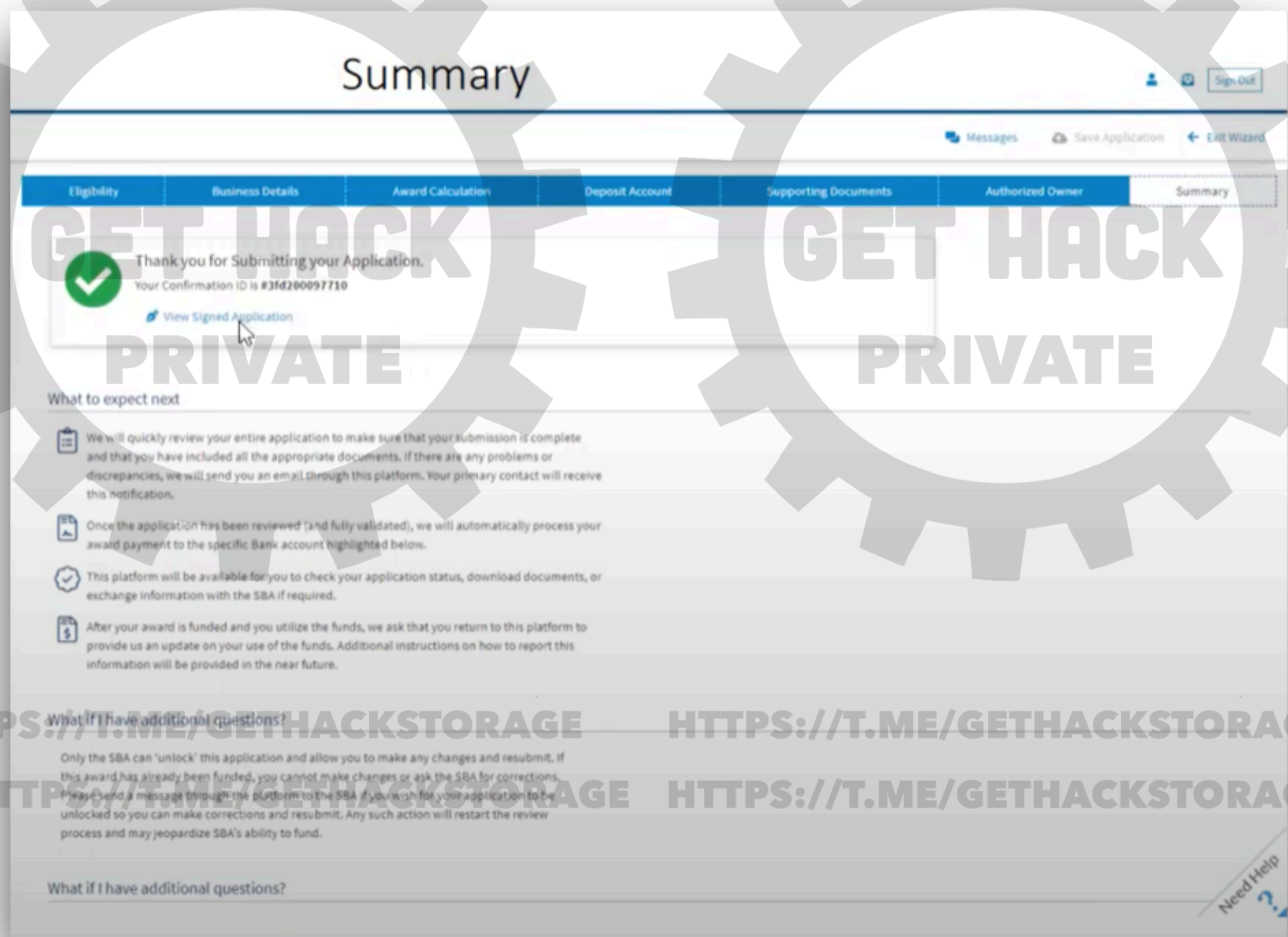
Теперь переходим к последнему разделу. В нём, как на первом скрине, вам будут показаны незаполненные детали и формы.



И будут показаны все заполненные данные для проверки.



Далее подтверждаем заявку, проходим окно росписи и получаем конфирм с вашим номером заявки.



После чего в течение 14 дней ваша заявка будет подтверждена, либо же отклонена, причины сможете узнать у тех. поддержки. В приоритетной группе рассмотрение по правилам такое же, но по факту проверяют за пару рабочих дней. Далее идёт проверка документов, после чего они могут запросить у вас доп. вериф, какой именно я сказать не могу, сам не сталкивался, знакомые аналогично. И после этого наступает уже окончательный вердикт и выплачивается сумма в течение 1 рабочего дня. В итоге весь процесс занимает до 3х недель, в приоритетном случае до 1й недели.
